LAGBAC DEBUTS NEW LOGO AT GALA

In conjunction with the 25th Anniversary Gala, LAGBAC decided it was time to take a fresh look at how it communicates its role in the community. "We wanted to create a singular image for the organization, that was professional without being stuffy and clearly communicated the pride we all feel in our LGBTIQ identity," said John Litchfield, President of LAGBAC.

The designer, Nathan Lagacy, who specializes in interactive design and branding, was thrilled at the opportunity to work on the project. Having been familiar with LAGBAC for several years (Lagacy's partner is a LAGBAC member), he welcomed the chance to help the organization renew its visual message. When interviewing members of LAGBAC at the beginning of the project, Lagacy said he recognized "an organization that has experienced significant growth and maturity over the past 25 years. . . , one that has led tremendous progress in LGBT issues, but still has a lot of work yet to do." "It was important to leverage the symbolism of the rainbow icon and palette into the logo in such a way that its meaning would be unmistakable," Lagacy said, "but sometimes doing so can come off as kitschy. This is a bar association, after all." The clean, pared-down design, emphasizing the "LAGBAC" name is meant to respect the organization's history while still being able to champion the work to be done in the next twenty-five years. It is also intended to be a visual statement that says "professional, confident, forward-thinking and unique, without being stuffy," Lagacy added.

LAGBAC'S 2012 VANGUARD AWARD HONOREE: BILL GREAVES

On Tuesday, April 24, 2012 the Chicago Bar Association hosted the 2012 Vanguard Awards at the Standard Club. LAGBAC honored William W. Greaves, the Former Liaison to the LGBT Communities at the City of Chicago. The Vanguard Awards honor members of the community who, through their efforts, have made the law and legal profession more accessible to and reflective of the whole, diverse community. LAGBAC Vice President, Nicole Bashor, gave Dr. Greaves a rousing introduction. Dr. Greaves then gave an interesting and humorous recount of his experiences and commitment to the LGBT community.

Dr. Greaves was born and raised in Queenstown, Maryland. He received his bachelor's degree in chemistry and English literature from Bucknell University in 1973 and his doctorate in inorganic chemistry and journalism from Iowa State University in 1978.

Dr. Greaves's career has been a mix of the two disciplines, working first as a chemist for Standard Oil of Indiana and, following that, as the physical sciences editor at Science magazine in Washington D.C., where his tenure coincided with the growing recognition of AIDS as a world-wide epidemic. At that time, Science was the leading American journal covering the disease. Dr. Greaves was given editorial responsibility for the epidemiology of AIDS and, during his time at the magazine, gained recognition as one of the world's experts on the transmission of HIV.

As Dr. Greaves saw his friends fall victim to AIDS, his desire to become an effective advocate for his community grew stronger. He joined DC Front Runners, a gay and lesbian running club devoted to raising funds for community causes in Washington. On his return to Chicago in 1988 he continued these activities with the affiliate group Frontrunners/Frontwalkers Chicago, eventually becoming that organization's President.

In 1995, Dr. Greaves was invited to become a member of the City of Chicago's Advisory Council on Gay and Lesbian Issues, where he began pursuing areas of policy development related to the integration of diverse groups and individuals into the fabric of city government and culture. In 2000, Mayor Richard M. Daley appointed Dr. Greaves to be the Council's Director. He served in that capacity until January 2012, acting as the Council's chief administrator and the Mayor's primary liaison to Chicago's LGBT communities.

During his tenure, Dr. Greaves shepherded the City's Gender Identity ordinance to passage, broadening the scope of the Chicago Human Rights and Fair Housing Ordinances to include protections for gender identity and naming transgender individuals as members of a protected class. He also amended the City of Chicago Personnel Rules to be in accord with the City's Human Rights Ordinance, and he co-wrote and edited the City's LGBT nondiscrimination statement and policy model for homeless shelters and its policy statement on LGBT substance abuse. Dr. Greaves also administered the Chicago Gay and Lesbian Hall of Fame, co-founded and directed the nation's only annual, government-sponsored military salute to LGBT veterans, and managed the official City ceremonies uniting 36 couples in Illinois's first civil unions.

Because of his background, experience, and accomplishments, Dr. Greaves is recognized throughout the city as an effective instrument for the integration and coordination of diverse populations into the cohesive, mutually respectful whole that is Chicago.



2012 ELECTIONS FOR LAGBAC BOARD

LAGBAC needs motivated legal professionals -- practitioners and students alike -- to serve on the Board of Directors. Terms begin on July 1, 2012. JEC UPDATE

LAGBAC's Judicial Evaluation Committee ("JEC") would like to broaden its reach by adding new members. The JEC screens judicial candidates seeking election or appointment, as well as sitting judges. Through investigation, screening and interviewing, the JEC determines whether candidates can be recommended for judicial positions. Most recently, the JEC screened all candidates running in the March 2012 primary elections. The committee is currently screening sitting judges who will be seeking retention in the November election. Although JEC membership does require some time commitment (usually no more than 10 hours over the course of 2-3 months), the committee's work is vital to ensure that the state judiciary is comprised of well qualified judges and to provide the public with an opportunity to cast an informed vote. LAGBAC AWARDED IVI-IPO AWARD

On April 30, 2012, LAGBAC was honored by the Independent Voters of Illinois – Independent Precinct Organization (“IVI-IPO”) with the 2012 Glynn Sudbery Award. This great honor was awarded to LAGBAC for its education of the electorate on judicial candidates through the Judicial Evaluations Committee, and for its advocacy for professionals in the legal community. LAGBAC was very honored to receive this award, and we thank our members, and specifically the Judicial Evaluations Committee, for their hard work and dedication.

REP. QUIGLEY ADDRESSES LAGBAC MEMBERS

On May 23, 2012, Congressman Quigley met with LAGBAC members in an informal community reception, hosted by the offices of Foley & Lardner LLP. In addressing the nearly 50 attendees, Quigley spoke to the challenges the divided Congress faces, as well as his work with Senator Mark Kirk on a variety of campaign finance reform and government accountability legislation. He also took questions about DOMA, ENDA, and immigration reform. Congressman Quigley was elected to serve Illinois’ 5th Congressional District in a special election in 2009 to fill the seat vacated by Chicago Mayor Rahm Emanuel, and was re-elected in 2010. He was recently appointed by Democratic party leadership as an assistant minority whip in the House.

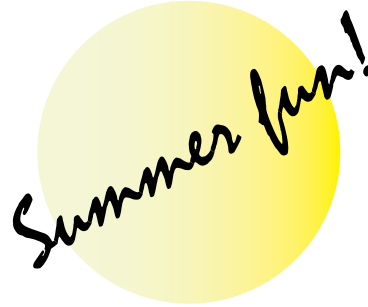

Lambda Legal Files Lawsuit Seeking Marriage for Same-sex Couples in Illinois

“By excluding these couples and their children from marriage, and relegating them to civil unions, our government has marked them as different and worth less than other Illinois families -- and that is exactly how others treat them.”

(Chicago, Wednesday, May 30, 2012) – Today, nearly one year after the civil union law took effect, Lambda Legal filed papers in the Circuit Court of Cook County, Chancery Division on behalf of 16 same-sex couples and their children seeking the freedom to marry.

“One year ago same-sex couples across the state were joined in civil unions. The experiences of the couples and the children in this suit show the hurt, confusion, and private bias that they have encountered as they have lived their lives,” said Camilla Taylor National Marriage Project Director for Lambda Legal based in the Midwest Regional Office in Chicago. Notably Taylor is the attorney who led the litigation effort and won marriage for same-sex couples in Iowa. “These couples and their children share a dream of being part of a married family. By excluding them from marriage, and relegating them to civil unions, our government has marked them as different and worth less than other Illinois families -- and that is exactly how others treat them. They have suffered disrespect in schools, workplaces, hospitals, and in their every-day interactions with government for long enough. They should have the freedom to marry – it’s just time,” Taylor added.

Lambda Legal represents 16 same-sex couples and their children from across the state of Illinois. The couples have been together between 6 to 48 years and 10 of the couples are raising children. The case argues that barring same-sex couples and their children from marriage is a violation of the Illinois Constitution’s guarantee of Equal Protection and Due Process.

“Civil unions do not satisfy Illinois’ guarantee of equality because they single out a group of people, treat them differently under the law, and deny them the fundamental right to marry,” said Christopher Clark, Senior Staff Attorney in Lambda Legal’s Midwest Regional Office based in Chicago. “We are taking this case to court because, in our democracy, it is the job of our courts to uphold the Constitution and protect individual freedom.”

Lead plaintiffs Jim Darby and Patrick Bova of Chicago have been together for over 48 years. Darby, who worked in the stockyards before enlisting to fight in the Korean War, and Bova, a librarian, met on the south side of Chicago and fell in love in 1963, and have been in a committed relationship ever since.

“After 48 years together we know very well what it means to love honor and cherish,” said Darby. “I have lived in Illinois all my life and I want to marry Patrick here. A civil union doesn’t reflect what we mean to each other.”

Lambda Legal is a national organization committed to achieving full recognition of the civil rights of lesbians, gay men, bisexuals, transgender people and those with HIV through impact litigation, education and public policy work.

In a separate case filed today, the American Civil Liberties Union of Illinois represents 9 same-sex couples seeking the freedom to marry. The coordinated marriage cases between Lambda Legal and the ACLU-IL signals the organizations' shared commitment to ensure that the government treats all families fairly.

Camilla Taylor, National Marriage Project Director and Christopher Clark, Senior Staff Attorney in Lambda Legal's Midwest Regional Office are handling the case for Lambda Legal. They are joined by Emily Nicklin, Jordan M. Heinz and Amy Crawford, partners at Kirkland & Ellis LLP in Chicago.
